

We understand how disappointing it is for travelers in the event they are forced to cancel their adventure, especially one that they have been looking forward to for a long time. But we too plan for these adventures for quite a long period prior to departure. Alaska Sea Adventures incurs significant expense provisioning, maintaining, training and crewing in preparation for a safe and successful charter season.

Therefore, we have a strict cancellation policy and we adhere to our Cancellation & Refund Policy for all travelers.

#### CANCELLATION & REFUND POLICY

If it becomes necessary for you to cancel your reservation, Alaska Sea Adventures requests written notice of cancellation via certified mail.

If we receive cancellation notice 150 or more days prior to departure date, your deposit will be refunded less a 10% cancellation fee. If we receive cancellation notice less than 150 days prior to charter date, we will gladly refund your deposit less a 10% cancellation fee only if your dates are rebooked. If your charter is rescheduled with a lower cost charter, you will receive a prorated portion.

Alaska Sea Adventures reserves the right to change or substitute crew members or make changes in our schedule or itinerary when necessary for the safety of our guests. In the unlikely event of mechanical breakdown, we reserve the right to make a timely substitution to another boat of comparable size and quality. If your charter is canceled or length reduced due to mechanical breakdown, we will refund the amount paid to us on a prorated basis. Alaska Sea Adventures reserves the right to cancel any charter at any time.

Furthermore, Alaska Sea Adventures and its cooperating agents shall not be liable for circumstances arising as a result of Acts of God, weather, communicable disease (e.g. Covid-19 virus, Norwalk virus, etc.), detention, annoyance, delays and expenses arising from quarantine, strikes, theft, pilferage, force majeure, military, political or terrorist action, civil disturbances, government restrictions, failure of any means of conveyance to arrive or depart as scheduled, discrepancies or changes in transit over which they have no control. Alaska Sea Adventures reserves the right to change the program fee, dates or itinerary with little or no notice. If such changes do occur, no refunds will be made beyond those described in our cancellation policy and Alaska Sea Adventures will not be liable for expenses incurred as a result of the change (such as air ticket change fees, etc.)

#### INSURANCE

If a traveler elects to NOT purchase Trip Cancellation Insurance, Trip Interruption Insurance and Air Medical Transport Insurance, the traveler assumes FULL responsibility for payments and/or financial losses resulting from an emergency or cancellation of the charter for ANY reason. (Please note that credit card 'insurance' will not adequately protect your charter investment.)
